- The relocation of Peterson Rd at IL Rte. 60 is included in the county's 2010-2015 Highway Improvement Program.
- Before a construction letting can be held an appropriation of \$11,040,000 of ½% Sales Tax for Transportation and Public Safety funds is required.

## RESOLUTION

**WHEREAS**, Peterson Road (County Highway 20) is a designated route on the county highway system; and

**WHEREAS,** the free flow of traffic along Peterson Road is beneficial to the safety and welfare to the State of Illinois and the county as a whole; and

**WHEREAS**, Lake County believes it would be beneficial to the safety and welfare of the motoring public if Peterson Road at its intersection with IL Rte. 60 could be relocated; and

**WHEREAS**, plans, specifications and estimates of cost for this improvement have been completed and this improvement is now ready to proceed to contract letting; and

WHEREAS, before a construction letting can be held, an appropriation of funds is needed.

**NOW, THEREFORE BE IT RESOLVED** by this County Board of Lake County, Illinois, that there is hereby appropriated \$11,040,000 of ¼% Sales Tax for Transportation and Public Safety funds for the relocation and reconstruction of Peterson Road at IL Rte. 60 and designated as Section 10-00098-11-CH.
