Joint resolution authorizing the execution of an agreement among Lake County, the Village of Kildeer and the Village of Deer Park for the widening improvements to Quentin Road (Rue Royale to White Pine Road) and the relocation of the proposed regional bike path along Quentin Road to an off-road route, and designated as Section 02-00051-08-WR.

- Quentin Rd (Rue Royale to White Pine Rd); Widening Improvements and Regional Bike Path Relocation: Villages of Killdeer and Deer Park Agreement.
- Quentin Rd from Rue Royale to White Pine will be widened to 5 lanes, including the improvement of the county legs of the intersection at US Rte. 12 within the Villages of Kildeer and Deer Park.
- The improvement will include a regional bike path in the Quentin Rd right-of-way.
- The Villages of Kildeer and Deer Park propose the relocation of the regional bike path from White Pine to Long Grove Rd off of the Quentin Rd right-of-way, with future construction by those entities.
- This resolution authorizes the execution of an intergovernmental agreement with the Villages of Kildeer and Deer Park for the Quentin Rd improvement.

## RESOLUTION

WHEREAS, Quentin Road (County Highway 5) is a designated route on the county highway system; and

WHEREAS, in order to ensure the free flow of traffic and the safety and welfare of the

motoring public, the County is desirous of widening Quentin Road from Rue Royale to White Pine Road, including the improvement of the county legs of the intersection at US Rte. 12, within Villages of Kildeer and Deer Park; and

WHEREAS, a regional bike path will be included with the right-of-way of Quentin Road; and

**WHEREAS,** the Villages of Kildeer and Deer Park have indicated their interest in relocating a portion of the regional bike path between White Pine Road and Long Grove Road (County Highway 43) to be an off-road bike path; and

**WHEREAS**, Lake County and the Villages of Kildeer and Deer Park are desirous of entering into an agreement stating the terms and conditions for said improvements to Quentin Road and the relocation of a portion of the regional bike path between White Pine Road and Long Grove Road to be an off-road bike path, a draft copy of which is attached hereto.

**NOW, THEREFORE BE IT RESOLVED**, by this County Board of Lake County, that the Chair of the County Board, the County Clerk, and the County Engineer of Lake County, Illinois, are authorized, and are hereby directed to enter into an agreement among Lake County and the Villages of Kildeer and Deer Park stating the terms and conditions for the improvements to Quentin Road and the relocation of a portion of the regional bike path between White Pine Road and Long Grove Road to be an off-road bike path. The County Engineer shall transmit in writing the final agreement to be executed by the Chair of the Lake County Board and the County Clerk.
