Joint resolution appropriating \$2,650,000 of Motor Fuel Tax funds for the resurfacing of St Mary's Road from IL Rte. 137 to IL Rte. 176 and designated as Section 08-00102-22-RS.

- St Mary's Road (*IL Rte 137 to IL Rte 176*) Resurfacing: Appropriation
- This resurfacing improvement has been identified within the county's Pavement Management System and is included in the 2010 program.
- Before a project letting can be held an appropriation of \$2,650,000 of Motor Fuel Tax funds is necessary.

## RESOLUTION

**WHEREAS,** St Mary's Road (*County Highway 41*) is a designated route on the county highway system; and

**WHEREAS,** it would be beneficial to the safety and welfare of the motoring public if St Mary's Road from IL Rte. 137 to IL Rte. 176 could be resurfaced; and

**WHEREAS**, plans, specifications and estimates of costs for this improvement have been completed and this improvement is now ready to proceed to contract letting; and

**WHEREAS**, before a construction letting can be held an appropriation of funds is needed.

**NOW, THEREFORE BE IT RESOLVED BY** this County Board of Lake County, Illinois, that there is hereby appropriated \$2,650,000 of Motor Fuel Tax funds for the resurfacing of St Mary's Road from IL Rte. 137 to IL Rte. 176 and designated as Section 08-00102-22-RS.
