Joint resolution appropriating \$2,125,000 of Matching Tax funds and \$375,000 of County Bridge Tax funds for the resurfacing of Riverwoods Road, from Illinois Route 60 to Illinois Route 22, and designated as Section 13-00136-09-RS.

- Riverwoods Road Resurfacing: Appropriation.
- Riverwoods Road is in need of resurfacing.
- This resurfacing improvement has been identified within the County’s pavement management system, and is included in the 2013 highway improvement program.
- Before a project letting can be held, an appropriation of \$2,125,000 of Matching Tax funds and \$375,000 of County Bridge Tax funds is necessary.

### RESOLUTION

**WHEREAS,** Riverwoods Road, County Highway 58, is a designated route on the County highway system; and

**WHEREAS,** it would be beneficial to the safety and welfare of the motoring public if Riverwoods Road, from Illinois Route 60 to Illinois Route 22, could be resurfaced; and

**WHEREAS,** plans, specifications, and estimates of costs for this improvement have been completed, and this improvement is now ready to proceed to contract letting; and

**WHEREAS,** before a construction letting can be held, an appropriation of funds is needed.

**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board, that there is hereby appropriated

\$2,125,000 of Matching Tax funds and \$375,000 of County Bridge Tax funds for the resurfacing of Riverwoods Road, from Illinois Route 60 to Illinois Route 22, and designated as Section 13-00136-09-RS.
