Joint resolution appropriating \$1,235,000 of Motor Fuel Tax funds for the resurfacing of Monaville Road, from Cedar Lake Road to Illinois Route 83, and designated as Section 12-00168-09-RS.

- Monaville Road Resurfacing: Appropriation.
- Monaville Road is in need of resurfacing.
- This resurfacing improvement has been identified within the County's pavement management system, and is included in the 2013 highway improvement program.
- Before a project letting can be held, an appropriation of \$1,235,000 of Motor Fuel Tax funds is necessary.

RESOLUTION

WHEREAS, Monaville Road, County Highway 55, is a designated route on the County highway system; and

WHEREAS, it would be beneficial to the safety and welfare of the motoring public if Monaville Road, from Cedar Lake Road to Illinois Route 83, could be resurfaced; and

WHEREAS, plans, specifications, and estimates of costs for this improvement have been completed, and this improvement is now ready to proceed to contract letting; and

WHEREAS, before a construction letting can be held, an appropriation of funds is needed.

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that there is hereby appropriated \$1,235,000 of Motor Fuel Tax funds for the resurfacing of Monaville Road, from Cedar Lake Road to Illinois Route 83, and designated as Section 12-00168-09-RS.
