Joint resolution making a supplemental appropriation of \$75,000 of Matching Tax funds for costs associated with the acquisition of necessary right-of-way for recently completed improvements to the intersection of Peterson Road (County Highway 20) and Illinois Route 60, and designated as Section 00-00098-11-CH.

- Peterson Road at Illinois Route 60 Right-of-Way Acquisition: Supplemental Appropriation.
- Improvements at the intersection of Peterson Road at Illinois Route 60 are complete.
- The County Board, at its meeting on October 10, 2006, approved the appropriation of \$900,000, and at its meeting on February 12, 2009, appropriated \$500,000 for the right-of-way acquisition, and associated costs, based on preliminary plans and specifications.
- A supplemental appropriation of \$75,000 of Matching Tax Funds is necessary for associated right-of-way acquisition expenses.

RESOLUTION

WHEREAS, Peterson Road, County Highway 20, is a designated route on the County highway system; and

WHEREAS, Illinois Route 60 is a designated route on the state highway system; and

WHEREAS, recently completed improvements to the intersection of Peterson Road and Illinois Route 60, which included the relocation and realignment of Peterson Road and the widening, resurfacing, and installation of permanent traffic control signals, are beneficial to the safety and welfare of the motoring public; and

WHEREAS, this County Board, at its meeting of October 10, 2006, did appropriate \$525,000 of County Bridge Tax funds and \$375,000 of Matching Tax funds, and at its meeting of February 12, 2009, did appropriate \$500,000 of matching Tax funds for acquisition of necessary right-of-way for said improvement; and

WHEREAS, a supplemental appropriation of funds for right-of-way acquisition is needed for associated right-of-way expenses.

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that there is hereby appropriated a supplemental amount of \$75,000 of Matching Tax funds for the acquisition of right-of-way for said improvement, and designated as Section 00-00098-11-CH.
