Joint resolution authorizing the execution of a joint agreement with the Illinois Department of Transportation for the use of \$344,250 of state Truck Access Route Program funds for the County's proposed improvement to Delany Road, from Sunset Avenue to York House Road, and designated as Section 00-00093-17-WR.

- Delany Road, from Sunset Avenue to York House Road: IDOT Agreement.
- Delany Road, from Sunset Avenue to York House Road, is to be improved by widening and reconstruction.
- IDOT has \$344,250 in Truck Access Route Program, TARP, funds available to offset cost of upgrading highways to accommodate 80,000 pound trucks.
- This resolution authorizes an agreement with IDOT for use of those funds for this improvement.

### **RESOLUTION**

**WHEREAS**, Delany Road, County Highway 22, is a designated route on the county highway system; and

**WHEREAS**, the free flow of traffic along Delany Road is beneficial to the safety and welfare to the State of Illinois and the county as a whole; and

**WHEREAS**, the State of Illinois and Lake County believe it would be beneficial to the safety and welfare of the motoring public if Delany Road, from Sunset Avenue to York House Road, could be improved by widening and reconstruction; and

**WHEREAS**, said improved roadway will be utilized by trucks with load limits of 80,000 pounds as a designated Class II Truck Route; and

**WHEREAS**, there is funding available, \$344,250, from the Illinois Department of Transportation for projects of this type, said funding available under the State's Truck Access Road Program; and

**WHEREAS**, the State of Illinois and Lake County are desirous of entering into an agreement for the above proposed improvement setting forth the terms and obligations to each agency.

**NOW, THEREFORE BE IT RESOLVED** that this Lake County Board, the County Clerk and the County Engineer of Lake County are authorized and they are hereby directed to execute an agreement on behalf of Lake County, pertaining to the financing of the above named improvement, a draft copy of which is attached hereto, and such authorization shall include any necessary subsequent amendments, as required by IDOT.

**BE IT FURTHER RESOLVED** that the County Engineer shall transmit, in writing, the final agreement and any amendments, as required by IDOT, to be executed by the County Board Chair and the County Clerk.

**BE IT FURTHER RESOLVED** that copies of this agreement, when executed in its final form, be submitted to the Illinois Department of Transportation for their approval and final processing.
