Joint resolution awarding a contract for the reconstruction of Fairfield Road, from north of Grand Avenue to south of Petite Lake Road, to the lowest responsible bidder Berger Excavating Contractors, Wauconda, Illinois, in the amount of \$862,062.89 and designated as Section 00-00180-01-RS.

- Fairfield Road Reconstruction, North of Grand Avenue to South of Petite Lake Road: Contract Award.
- This improvement is included in the 2013 Highway Improvement Program.
- A total of two bids were received, ranging from \$862,062.89 to \$870,359.04, and the lowest responsible bidder is Berger Excavating Contractors, Wauconda, Illinois, in the amount of \$862,062.89.

RESOLUTION

WHEREAS, pursuant to authority granted by this Lake County Board, the County Engineer heretofore called for sealed bids, by publication, for the reconstruction of Fairfield Road, from north of Grand Avenue to south of Petite Lake Road, and designated as Section 00-00180-01-RS; and

WHEREAS, pursuant to said publication calling for said bids, sealed bids were received and opened on April 16, 2013, at 10:00 a.m., at the Lake County Division of Transportation in Libertyville, Illinois; a tabulation of said bids being as follows:

Berger Excavating Contractors
Wauconda, IL

Curran Contracting Company

WHEREAS, the Public Works and Transportation Committee, the County Engineer, and the Purchasing Agent have examined each bid, and it appears that the lowest responsible bidder is Berger Excavating Contractors, Wauconda, Illinois, their bid being \$862,062.89 based on estimated quantities and unit prices; and

WHEREAS, this Lake County Board, by prior resolution at its meeting of February 12, 2013, appropriated \$1,395,000 of Matching Tax funds for the Fairfield Road Reconstruction, and designated as Section 00-00180-01-RS.

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that a contract be awarded to said, Berger Excavating Contractors, Wauconda, Illinois, in accordance with their bid of \$862,062.89, based on estimated quantities and unit prices, and that the Purchasing Agent, the County Clerk and the County Engineer of Lake County be authorized and are hereby directed to enter into a contract with said low bidder for the Fairfield Road Reconstruction, as described above, and designated as Section 00-00180-01-RS.

BE IT FURTHER RESOLVED that in as much as such estimated quantities are the best approximation that can be determined at this time, these quantities may be added to, deducted from, or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 without further Board action, provided the final cost chargeable under the funds appropriated does not exceed the appropriation.
