Joint resolution awarding a contract for the removal, replacement or refurbishment of pavement markings on the bituminous and concrete pavements of various County highways to the lowest responsible bidder Superior Road Striping, Inc., Melrose Park, Illinois, in the amount of \$316,197.92, and designated as Section 13-00000-15-GM.

- 2013 Pavement Marking Replacement: Contract Award.
- The County has miles of pavement markings for medians, lane lines and cross walks on bituminous and concrete pavements.
- These markings last longer than paint, but eventually require replacement.
- This replacement project is in the 2013 program.
- A total of four bids were received, ranging from \$316,197.92 to \$443,205.86, and the lowest responsible bidder is Superior Road Striping, Inc., Melrose Park, Illinois, in the amount of \$316,197.92.

### RESOLUTION

**WHEREAS**, pursuant to authority granted by this Lake County Board, the County Engineer heretofore called for sealed bids, by publication, for the removal or replacement of bituminous and concrete pavement markers on various County highways, and designated as Section 13-00000-15-GM; and

**WHEREAS**, pursuant to said publication and calling for said bids, sealed bids were received and opened on June 18, at 10:00 AM at the Lake County Division of Transportation in Libertyville, Illinois; a tabulation of said bids as follows:

**WHEREAS**, the Public Works and Transportation Committee, the County Engineer and the Purchasing Agent have examined each bid, and it appears that the lowest responsible bidder is Superior Road Striping, Inc., Melrose Park, Illinois, their bid being \$316,197.92, based on estimated quantities and unit prices; and

**WHEREAS**, this Lake County Board, by prior resolution at its meeting of May 14, 2013, appropriated \$835,000 of Motor Fuel Tax funds for the 2013 removal or replacement of bituminous and concrete pavement markers on various county highways and designated as Section 13-00000-15-GM; and.

**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board that a contract be awarded to said Superior Road Striping, Inc., Melrose Park, Illinois, in accordance with their bid of \$316,197.92 based on estimated quantities and unit prices and that the Purchasing Agent, the County Clerk, and the County Engineer of Lake County be authorized, and they are hereby directed to enter into a contract with said low bidder for the removal or replacement of bituminous and concrete pavement markers on various county highways.

**BE IT FURTHER RESOLVED** that in as much as such estimated quantities are the best approximation that can be determined at this time, these quantities may be added to, deducted from, or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 without further Board action, providing the final cost chargeable to the funds appropriated does not exceed the appropriation.

**BE IT FURTHER RESOLVED** that this award be processed by the County Engineer for final approval of the Illinois Department of Transportation in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County dated January 18, 2013.
