Resolution authorizing a contract with Suburban Communications, Inc. of Palatine, Illinois for the installation of voice and data low voltage cabling for the remodeling of floors six through nine in the amount of \$120,000.

- There is a need to contract with a single vendor for the installation of voice and data low voltage cabling for the remodeling of floors six through nine in the administrative tower in Waukegan.
- Lake County extended bid requests to 32 vendors with responses from four firms.
- Sealed bids were received for the administrative tower project with proposals ranging from \$120,000 to \$146,799.
- Suburban Communications, Inc., Palatine, Illinois is the lowest responsive and responsible bidder who best meets the needs of the County for the installation of voice and data low voltage cabling for the remodeling of floors six through nine in the administrative tower in Waukegan with the contract amount of \$120,000.

**WHEREAS**, there is a need to contract with a single vendor for the installation of voice and data low voltage cabling for the remodeling of floors 6-9 in the administrative tower in Waukegan, IL, and

**WHEREAS**, in accordance with Section 5-102 of the Lake County Purchasing Ordinance, bids were called for by publication for the installation of voice and data low voltage cabling for the remodeling of floors 6-9 and in other Lake County Facilities as needed; and

**WHEREAS**, subsequent to said publication, an Invitation to Bid was extended to 32 vendors with responses from four firms; and

**WHEREAS**, sealed bids were received for the administrative tower project with responses ranging from \$120,000 to \$146,799; and

**WHEREAS**, Suburban Communications, Inc., Palatine, IL is the lowest responsive and responsible bidder who best meets the needs of the County for the installation of voice and data low voltage cabling for the remodeling of the floors 6-9 in the administrative tower in Waukegan, IL in the contracted amount of \$120,000.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that the Purchasing Agent is authorized to enter into a contract with Suburban Communications, Inc. of Palatine, IL for the installation of voice and data low voltage cabling for the remodeling of floors 6-9 in the amount of \$120,000 charging to account #101-1103340-82020.
