- The American Rescue Plan Act of 2021 appropriated \$5 billion to provide housing, services, and shelter to individuals experiencing homeless and other vulnerable populations.
- The funding will be administered through State and local Participating Jurisdictions (PJs) qualified to receive annual HOME funds.
- The Lake County HOME Consortium is a qualified PJ and has been awarded \$6,025,377 of HOME-ARP funds.

### RESOLUTION

**WHEREAS,** The American Rescue Plan Act of 2021 appropriated \$5 billion to provide housing, services, and shelter to individuals experiencing homeless and other vulnerable populations; and

**WHEREAS,** HOME-ARP funds will be administered through State and local Participating Jurisdictions PJs qualified to receive annual HOME funds; and

**WHEREAS**, The Lake County HOME Consortium is a qualified PJ and has been awarded \$6,025,377 of HOME-ARP funds.

**NOW, THEREFORE, BE IT RESOLVED**, that by this County Board of Lake County, Illinois, that Chair of the Lake County Board or their designee is hereby authorized to execute the necessary documents to accept HOME-ARP funds; and

**BE IT FURTHER RESOLVED**, that an emergency appropriation in the amount of \$6,025,377.00 is hereby authorized in the Fiscal Year 2021 budget in the Fund 740 HUD Grants budget as detailed in the attachment.
