Ordinance establishing and appointing members to the Lake County Board of Review Advisory Group.

- The Board of Review Advisory Group would bring together the various constituencies that participate in the assessment appeal process.
- This effort would provide another opportunity for stakeholders to provide input into the assessment appeal process.
- The group will commence with meetings this summer and complete their work with the Board of Review next spring.

**WHEREAS**, the Lake County Board and the Lake County Board of Review seek public input regarding the property assessment appeal process; and

**WHEREAS**, this group will commence their meetings and report any recommendations to the Revenue, Records and Legislation Committee at their first scheduled Committee meeting in May 2010; and
