- This resurfacing improvement has been identified within the county's Pavement Management System and is included in the 2010 program.
- Before a project letting can be held an appropriation of \$1,345,000 of 1/4% Sales Tax for Transportation and Public Safety funds is necessary.

## RESOLUTION

**WHEREAS,** Pulaski Drive (*County Highway 78*) is a designated route on the county highway system; and

**WHEREAS**, it would be beneficial to the safety and welfare of the motoring public if Pulaski Drive from IL Rte 43 to IL Rte 131 could be resurfaced; and

**WHEREAS,** plans, specifications and estimates of costs for this improvement have been completed and this improvement is now ready to proceed to contract letting; and

WHEREAS, before a construction letting can be held an appropriation of funds is needed.

**NOW, THEREFORE BE IT RESOLVED BY** this County Board of Lake County, Illinois, that there is hereby appropriated \$1,345,000 of 1/4% Sales Tax for Transportation and Public Safety
