Joint resolution authorizing a contract with Peter Baker and Son Company, Lake Bluff, Illinois, for resurfacing portions of Quentin Road, including the replacement of a guardrail and the stabilization of an embankment, in the amount of \$1,325,052.23, and designated as Section 10-00090-14-RS.

- Quentin Road Resurfacing, Illinois Route 22 to Old McHenry Road: Contract Award.
- Quentin Road is in need of resurfacing.
- These resurfacing improvements have been identified within the County's pavement management system and are included in the 2012 program.
- In addition, a guardrail will be replaced and the stabilization of an embankment will be completed.
- A total of two bids were received ranging from \$1,325,052.23 to \$1,493,530.28 with the lowest responsible bidder being Peter Baker and Son Company, Lake Bluff, Illinois, in the amount of \$1,325,052.23.

RESOLUTION

WHEREAS, pursuant to authority granted by this Lake County Board, the Acting County Engineer heretofore called for sealed bids, by publication, for the resurfacing of Quentin Road, including the replacement of a guardrail and the stabilization of an embankment, and designated as Section 10-00090-14-RS-RS; and

WHEREAS, pursuant to said publication calling for said bid, sealed bids were received and opened on July 24, 2012, at 10:00 a.m. at the Lake County Division of Transportation in Libertyville, Illinois; a tabulation of said bids being as follows:

Peter Baker & Son Company Lake Bluff, IL \$1,325,052.23

Curran Contracting Company Crystal Lake, IL \$1,493,530.28

WHEREAS, the Public Works and Transportation Committee, the Acting County Engineer and the Purchasing Agent have examined each bid, and it appears that the lowest responsible bidder is Peter Baker & Son Company, Lake Bluff, Illinois, their bid being \$1,325,052.23 based on estimated quantities and unit prices; and

WHEREAS, this Lake County Board, by prior resolution at its meeting of May 8, 2012, appropriated \$2,110,000 of Motor Fuel Tax funds for the resurfacing of Quentin Road, including the replacement of a guardrail and the stabilization of an embankment.

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that a contract be awarded to said Peter Baker & Son Company, Lake Bluff, Illinois, in accordance with their bid of \$1,325,052.23, based on estimated quantities and unit prices, and that the Purchasing Agent, the County Clerk, and the Acting County Engineer of Lake County be authorized and they are hereby directed to enter into a contract with said low bidder for the resurfacing of Quentin Road, from Illinois Route 22 to Old McHenry Road, including the replacement of a guardrail and the stabilization of an embankment and designated as Section 10-00090-14-RS.

BE IT FURTHER RESOLVED that in as much as such estimated quantities are the best approximation that can be determined at this time, these quantities may be added to, deducted from, or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 without further Board action, providing the final cost chargeable to the funds appropriated does not exceed the appropriation.

BE IT FURTHER RESOLVED that this award be processed by the Acting County Engineer for final approval of the Illinois Department of Transportation in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County, dated January 22, 2003.
