Joint resolution authorizing the Lake County Workforce Development Department to enter into an agreement with X-treme Cleaning Services, Grayslake in the amount of \$21,120.

- The Lake County Workforce Investment Board was awarded a grant to fund on the job training.
- The grant funds 90% of the wages paid to dislocated workers while they are being trained.
- The agreement is with X-treme Cleaning Services, a residential and commercial cleaning and water damage restoration company located in Grayslake, Illinois.
- One of the new hires will be trained as a Cleaning and Water Restoration Technician and the other as a Manager of Office and Administrative Support.
- Both hires are long-term unemployed Lake County residents.
- The cost of training is \$19,008 (Workforce Development) plus \$2,112 (employer) for a total cost of \$21,120. The total training hours is 960 per trainee at a wage rate of \$11 each per hour.

### RESOLUTION

**WHEREAS**, the Lake County Workforce Investment Board has approved a two-year ARRA-National Emergency On The Job Training Grant, whereby long term dislocated workers can have their wages paid by as much as 90% while they are being trained; and

**WHEREAS**, the Lake County Workforce Development Department wishes to enter into an agreement with X-treme Cleaning Services, for the purpose of conducting on the job training for 2 newly hired employees; and

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that the Lake County Workforce Development Department is hereby authorized to enter into an Agreement with X-treme Cleaning Services in the amount of \$19,008 for the purpose of training 2 on the job training workers charging the costs thereof to account #750-4042040-79940-000-000-000-WDNEG.
