Joint resolution authorizing the Lake County Workforce Development Department to enter into an agreement with Advanced Computer Training, Inc. in the amount of \$21,283.20.

- The Lake County Workforce Development Department was awarded a grant to fund on the job training.
- The grant funds 90% of the wages paid to dislocated workers while they are being trained.
- The agreement is with Advanced Computer Training, Inc., an information technology training institution located in Glenview, Illinois.
- The new hire is a long-term unemployed Lake County resident who will receive program management and information technology training.
- The cost of training is \$19,154.88 (Workforce Development) plus \$2,128.32 (employer) for a total cost of \$21,283.20. The total training hours is 960 at a wage rate of \$22.17 per hour.

### RESOLUTION

**WHEREAS**, the Lake County Workforce Investment Board has approved a two-year ARRA-National Emergency On The Job Training Grant, whereby long term dislocated workers can have their wages paid by as much as 90% while they are being trained; and

**WHEREAS**, the Lake County Workforce Development Department wishes to enter into an agreement with Advanced Computer Training, Inc. (ACT), for the purpose of conducting on the job training for 1 newly hired employee; and

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that the Lake County Workforce Development Department is hereby authorized to enter into an Agreement with Advanced Computer Training, Inc.(ACT) in the amount of \$19,154.88 for the purpose of training 1 on the job training worker charging the costs thereof to account #750-4042040-79940-

000-000-000-WDNEG.
