- Friends for Health awarded \$9,000 to support specialty care services for North Shore Health Center patients.
- The Jordan Michael Filler Foundation donated \$1,000 for the Substance Abuse Program to purchase Adapt Naloxone kits.

### RESOLUTION

**WHEREAS**, the Lake County Health Department and Community Health Center has received a grant and donation increase delivered by our Behavioral Health and Primary Care Service Areas; and

**WHEREAS**, these dollars will provide a legitimate increase in services to Lake County with no impact on local taxes; and

**WHEREAS**, this donation and grant amount totaling \$10,000 has not been previously appropriated, having been awarded after adoption of the Fiscal Year 2016 budget; and

**WHEREAS**, the proposed appropriation will be fully offset by the above referenced items thereby not requiring the expenditure of local tax revenue.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that an

emergency appropriation in the amount of \$10,000 is hereby authorized in the Health Department budget as identified on the listing of expense and revenue budget modifications attached hereto and made part hereof; and

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, that the revenue budgets as identified on the attached listing be modified as provided by increased funding from the following:

Friends for Health - Specialty Care, \$9,000;  
Jordan Michael Filler Foundation - Substance Abuse Program, \$1,000.
