Resolution authorizing a contract for consulting services for the implementation of Oracle Business Intelligence (BI) Analytics; Enterprise Asset Management (eAM); and the Hyperion solution for Public Sector Planning and Budgeting, with the consulting firm AST, Naperville, IL in the amount of \$2,511,392.

- Oracle, the County's financial system in use since 2003, is comprised of a number of separate but linked modules.
- Oracle makes continuous improvements and changes to these modules.
- Lake County's need for and utilization of these modules continues to change in response to functional needs and Oracle driven changes.
- At this time, specific changes impacting the use of the system include the discontinuation of the current budget module, as well as the need for an inventory, work order and asset management system.
- On February 14, 2012, the Lake County Board approved the purchase of a licensing software package
 for both current and additional operational and technical functionality within the BOSS software system
 to address these needs.
- As identified at that time, third party services are required to successfully implement the software.
- A Request for Proposal (RFP) was issued to 22 vendors and proposals were received from seven firms.
- A selection committee comprised of staff from the Division of Transportation, Public Works, Human Resources, Finance and Administrative Services, Health Department, Circuit Courts, Lake County Sheriff and the Purchasing Division recommend the services of AST, Naperville, IL as the firm who best meets the needs of the County based on the RFP evaluation criteria.
- The contract includes implementation and consulting services at a contract amount not to exceed \$2,511.392.

WHEREAS, in accordance with Section 5-102 of the Lake County Purchasing Ordinance, proposals were called for by publication for the implementation services of various modules of Oracle; and

WHEREAS, a Request for Proposal (RFP) was issued for the implementation services of various modules of Oracle; and

WHEREAS, the RFP was sent to 22 vendors, sealed proposals were received from seven firms and opened in the County Building, Waukegan, Illinois on March 28, 2013, at 2:00 p.m.; and

WHEREAS, a selection committee comprised of staff from the Division of Transportation, Public Works, Human Resources, Finance and Administrative Services, Information Technology, Health Department, Circuit Courts, Lake County Sheriff and the Purchasing Division all recommend the services of AST, Naperville, IL as the firm who best meets the needs of the County based on the RFP evaluation criteria; and

WHEREAS, the contract includes third party implementation and consulting services.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is authorized to enter into a contract with AST, Naperville, IL, for the implementation of the following Oracle modules, Hyperion, Business Intelligence and Enterprise Asset Management in the amount not to exceed \$2,511,392 charging the costs to account #101-1103440-84040.
