- Lake County desires to enter into a two-year contract, with renewals with Federal Companies of Waukegan for delivery services and storage of election supplies (signs, cones, voting booths) for the Lake County Clerk.
- Invitations for Bids were extended to ten (10) vendors; sealed bids were received from five (5) vendors and opened on September 15, 2009.
- Federal Companies of Waukegan, IL is the lowest responsive and responsible bidder in the amount of \$79,072 per year; three other bids received ranged from \$79,276.48 to \$101,400 and one nonresponsive bid was received.
- This service will be charged to account 101-2110020-72560 for \$16,320 and to account \$101-2110020-79940 for \$62,752.

**WHEREAS,** in accordance with Section 4-102 of the Lake County Purchasing Ordinance, bids were called for by publication for Delivery Services and Storage of Election Equipment and Supplies for the Lake County Clerk; and

WHEREAS, Invitations for bids were extended to ten (10) vendors; and

**WHEREAS**, sealed bids were received from five (5) vendors and opened in the County Building, Waukegan, IL on September 15, 2009 at 2:00 p.m.; and

**WHEREAS,** Federal Companies, Waukegan, IL is the lowest responsive and responsible in the estimated amount of \$79,072 per year; three other bids received ranged from \$79,276.48 to \$101,400 and one non-responsive bid was received.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby authorized to enter into a two-year contract with renewals with Federal Companies, Waukegan, IL in the estimated amount of \$79,072 per year for Delivery Services and Storage of Election Equipment and Supplies, charging \$16,320 to account 101-2110020-72560-000-000-0000000 and

\$62,752 to account 101-2110020-79940-000-000-000-0000.
