Joint resolution authorizing the execution of the necessary documents to submit a substantial amendment to the 2008 Annual Action Plan for the Homelessness Prevention and Rapid Re-Housing Program (HPRP).

- The U.S. Department of Housing and Urban Development (HUD) announced the availability of approximately \$1.5 billion for the Homelessness Prevention & Rapid Re-Housing Program (HPRP) as part of the American Recovery & Reinvestment Act (ARRA).
- Lake County is eligible to apply for \$1,057,106 of this funding by submitting a substantial amendment to its 2008 Annual Action Plan.
- Staff has sought input from homeless service agencies and other stakeholders to determine an appropriate plan for the use of funds.
- Subrecipients will be determined at a later date through a competitive application process.
- The plan must be turned in to HUD by May 18.

**WHEREAS**, the U.S. Department of Housing and Urban Development is making available some \$1.5 billion for the Homelessness Prevention & Rapid Re-Housing Program (HPRP) as part of the American Recovery & Reinvestment Act (ARRA); and

**WHEREAS**, Lake County is eligible to receive \$1,057,106 for homeless and housing services if the County submits a substantial amendment to its 2008 Annual Action Plan; and

**WHEREAS**, Community Development staff has sought input from homeless service agencies and other stakeholders to determine an appropriate use of funds; and

WHEREAS, a competitive application process with selected subrecipients will take place at a

later date; and

**WHEREAS**, these funds will go to meeting a goal in Lake County's 10-Year Plan to End Homelessness.

**NOW, THEREFORE BE IT RESOLVED**, by this County Board of Lake County, Illinois, that the Chairman of the Lake County Board or her designee is hereby authorized to execute the necessary documents to submit a substantial amendment to its 2008 Annual Action Plan to the U.S. Department of Housing and Urban Development for the Homelessness Prevention & Rapid Re-Housing Program (HPRP).
