Joint resolution accepting a grant from the Illinois Department of Veterans Affairs to provide dental service assistance to veterans of Lake County and authorizing an emergency appropriation totaling \$50.000.

- The Illinois Department of Veterans Affairs has awarded a grant of \$50,000 to provide dental services to veterans of Lake County.
- Dental assistance is already provided by the Veterans Assistance Commission; however, the additional grant revenue will allow more veterans to benefit from this service.
- There are no matching funds for this grant, which will expire on January 29, 2013.

**WHEREAS**, the Veterans Assistance Commission (VAC) of Lake County has been approved for a one-time grant totaling \$50,000 from the Illinois Department of Veterans Affairs to provide additional funding assistance to veterans of Lake County for dental services; and

**WHEREAS**, the VAC of Lake County currently provides general assistance to veterans through its budgeted Assistance to Veterans account; and

**WHEREAS**, additional funding is necessary to meet the demonstrated need for dental services of Lake County veterans; and

**WHEREAS**, the Illinois Department of Veterans Affairs has extended a one-time grant agreement through January 29, 2013 to assist with this need, with no requirement of matching county funds; and

**WHEREAS**, the VAC has established guidelines for the proper distribution of funds and payment of dental services; and

**WHEREAS**, an emergency appropriation is necessary to formally accept this grant agreement for \$50,000 associated with Revenue Account 208-3700010-45333-000-000-000-0000 and Expense Account 208-3700010-71340-000-000-000-00000; and

**NOW, THEREFORE, BE IT RESOLVED**, by the County Board of Lake County, Illinois that the acceptance and execution of a one-time \$50,000.00 grant agreement through January 29, 2013 by the Illinois Department of Veterans Affairs grant to the Lake County Veterans Assistance Commission is hereby approved to provide additional assistance to veteran's of Lake County for dental services; and

**BE IT FURTHER RESOLVED**, that the Veterans Assistance Commission shall serve as project director for the program, and accurate records of all necessary grant compliance requirements shall be maintained by the Veterans Assistance Commission.
