Joint resolution appropriating \$3,400,000 of Motor Fuel Tax funds for the resurfacing of Monaville Road from IL Rte. 59 to Cedar Lake Road and also for the resurfacing of Deep Lake Road from IL Rte. 173 to Grass Lake Road and designated as Section 09-00999-09-RS.

- Monaville Road (IL Rte. 59 to Cedar Lake Road) and Deep Lake Road (IL Rte. 173 to Grass Lake Road) Resurfacing: Appropriation
- This resurfacing improvement has been identified within the county’s Pavement Management System and is included in the 2010 program.
- Before a project letting can be held an appropriation of \$3,400,000 of Motor Fuel Tax funds is necessary.

RESOLUTION

WHEREAS, Monaville Road (*County Highway 55*) and Deep Lake Road (*County Highway 36*) are designated routes on the county highway system; and

WHEREAS, it would be beneficial to the safety and welfare of the motoring public if Monaville Road from IL Rte. 59 to Cedar Lake Road (*County Highway 28*) and also if Deep Lake Road from IL Rte. 173 to Grass Lake Road (*County Highway 18*) could be resurfaced; and

WHEREAS, plans, specifications and estimates of costs for this improvement have been completed and this improvement is now ready to proceed to contract letting; and

WHEREAS, before a construction letting can be held an appropriation of funds is needed.

NOW, THEREFORE BE IT RESOLVED BY this County Board of Lake County, Illinois, that there is hereby appropriated \$3,400,000 of Motor Fuel Tax funds for the resurfacing of Monaville Road from IL Rte. 59 to Cedar Lake Road and also for the resurfacing of Deep Lake Road from IL Rte. 173 to Grass Lake Road and designated as Section 09-00999-09-RS.

BE IT FURTHER RESOLVED that this appropriation be processed by the County Engineer for final approval of the Illinois Department of Transportation in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County, dated January 22, 2003.
