Resolution ratifying an Emergency Procurement authorized by the Director of Human Resources with United Services by Permaco, Lake Bluff IL.

- On October 26, 2008 a water main ruptured in Gages Lake flooding a residence at 33706 Lake Shore Drive, Wildwood, IL.
- This emergency condition necessitated water mitigation services including removal of the homeowners personal belongings, storage, cleaning and reconstruction services.
- Lake County did not have the resources available to provide the necessary services.
- This resolution is to ratify an Emergency Procurement authorized by the Director of Human Resources with United Services of Permaco, Lake Bluff, IL, in the amount of \$58,980.89.
- The purchase was charged to account #206-1440010-71420-000-000-000-00000.

**WHEREAS**, in accordance with Section 6-103 of the Lake County Purchasing Ordinance, an emergency condition existed due to a water main rupture in Gages Lake on October 26, 2008, and

**WHEREAS**, the water main rupture flooded the residence at 33706 Lake Shore Drive, Wildwood, II, and there was a need for water mitigation services including removal of the homeowners personal belongings, storage, cleaning and reconstruction services to mitigate the water damage; and

**WHEREAS**, Lake County did not have the resources available to perform the necessary services; and

**WHEREAS**, the Director of Human Resources certified that an emergency condition existed necessitating immediate action; and

WHEREAS, the Purchasing Agent issued an Emergency Purchase Order for the services.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois
