- Lake County extended an Invitation to Bid to seven vendors and received four sealed bids ranging from \$31,516.80 to \$40,047.27
- The Sign Outlet Store, Lisle, IL is the lowest responsive and responsible Bidder at \$31,516.80, charging the cost to account 214-4300030-84030-000-000-000-00000.

**WHEREAS,** in accordance with Section 4-102 of the Purchasing Ordinance of Lake County, IL bids were called for by publication for a Sign Shop Printer for the Division of Transportation; and

**WHEREAS,** subsequent to said publication, Invitations to Bid were extended to seven vendors; and

**WHEREAS**, sealed bids were received from four (4) vendors and opened in the County Building, Waukegan, Illinois on Friday, February 27, 2009, at 2:00 p.m.; and

**WHEREAS**, Chicago Sign Outlet Store, Lisle, IL is the lowest responsive and responsible bidder in the amount of \$31,516.80; other bids were received from Rayco, Chicago, IL, \$32,065, Midwest Sign and Screen, Franklin, WI, \$32,750, and Metrokonnect, LLC., Naperville, IL, \$40,047.27.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that the Purchasing Agent is authorized to enter into a contract with the Sign Outlet Store, Lisle, IL in the
