Joint Resolution authorizing execution of an Agreement for Professional Engineering Services with Manhard Consulting, Ltd. for design of the W.W. Grainger Lift Station and Force Main Improvements Project.

- As part of an Agreed Order entered into between the County, the Village of Mettawa and Millineum Maintenance, Inc. the County has agreed to make improvements to the existing W.W. Grainger lift station and force main system to accommodate projected flows identified in the Agreed Order.
- These improvements will require engineering plans and specifications be prepared by a qualified professional engineering firm.
- Three engineering firms were selected to submit qualifications for this design work.
- Based on staff evaluations, Manhard Consulting, Ltd. of Waukegan, IL is the most qualified firm and a scope of services was negotiated for this project.
- Committee authorization is requested to execute an Agreement for Professional Engineering Services with Manhard Consulting, Ltd. in the amount of \$147,290 for the design and drawing preparation of the W.W. Grainger Lift Station and Force Main Improvements Project, charging the cost thereof to Account No. 610-4833198-71170-48310.

WHEREAS, an Agreed Order between Millineum Maintenance Management, Inc., Capital Development Group, LLC, Village of Mettawa, Deerpath Farms Subdivision, LLC, Fred Baird, and County of Lake was executed by County Board action at the July 8, 2008 meeting; and

WHEREAS, the Agreed order reflected certain terms and facility improvements would be made to the County's W.W. Grainger Lift Station and Force Main to accommodate flows from parcels included in the Agreed Order, and; and

WHEREAS, it is necessary to prepare engineering plans and specifications by a qualified professional engineering firm for such improvements; and

WHEREAS, the Public Works Department solicited and received proposals from three professional engineering firms; and

WHEREAS, the Public Works Department evaluated the proposals based on several criteria and determined that Manhard Consulting, Ltd. was the most qualified firm to provide professional engineering services for this project; and

WHEREAS, Lake County has had a prior satisfactory relationship for professional services with Manhard Consulting, Ltd.; and

WHEREAS, an Agreement has been negotiated with Manhard Consulting, Ltd. to provide the necessary engineering services; and

WHEREAS, execution of an Agreement for Professional Services must be authorized by Resolution of this County Board.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby authorized and directed to execute the attached Agreement for Professional Services with Manhard Consulting, Ltd., Waukegan, IL in the amount of \$147,290 for engineering services associated with the W.W. Grainger Lift Station and Force Main Improvements Project and charging the costs thereof to Account No. 610-4833198-71170-48310.
