Joint resolution appropriating \$100,000 of Motor Fuel Tax funds for annual bituminous shoulder maintenance of various roads on the county highway system and designated as Section 10-00000-09 -GM.

- 2010 Bituminous Shoulder Maintenance Appropriation
- Each year the county undertakes maintenance of its bituminous shoulders to preserve the surface quality.
- Resurfacing is done on isolated sections of shoulders that are not on the list of resurfacing/rehabilitation/reconstruction projects as programmed in the 5-year program from the results of the pavement management system.
- Before a project letting can be held an appropriation of \$100,000 of Motor Fuel Tax funds is necessary.

RESOLUTION

WHEREAS, in order to preserve the condition of the bituminous shoulders on the designated routes on the county highway system, the Division of Transportation annually undertakes the shoulder maintenance, where necessary, on various county highways; and

WHEREAS, the estimated cost of bituminous shoulder maintenance activities for 2010 is \$100,000.

NOW, THEREFORE BE IT RESOLVED by this County Board of Lake County, Illinois that there is hereby appropriated \$100,000 of Motor Fuel Tax funds for bituminous shoulder maintenance for fiscal year 2010 on various county highways and designated as Section 10-00000-09-GM.
