- This contract will cost the County an estimated annual amount of \$33,410, charging the costs thereof to accounts 101-3004110-79940 and 101-3004110-64010.

WHEREAS, in accordance with Section 4-102 of the Lake County Purchasing Ordinance, bids were called for by publication for Bullet Trap Environmental Cleaning services for the Lake County Shooting Range; and

WHEREAS, subsequent to said publication, invitations for bids were extended to the nine (9) firms; and

WHEREAS, sealed bids were received from three (3) firms and opened in the County Building, Waukegan, Illinois on Friday, March 12, 2010 at 2:00 p.m.; and

WHEREAS, Greenbay Lead, Inc., Greenbay, WI is the lowest responsive and responsible bidder in the estimated annual amount of \$33,410, other bids received ranged from \$41,490 to \$51,920 per year.
