Resolution authorizing a contract with KJWW Engineering Consultants, PC of Chicago, Illinois for engineering design services to replace the fire alarm system for Division of Transportation buildings in Libertyville, IL.

- There is a need to retain a qualified engineering firm to provide engineering services to replace the fire alarm system for the Division of Transportation buildings in Libertyville.
- Lake County has a satisfactory relationship with KJWW Engineering Consultants PC of Chicago, Illinois on similar work.
- Facilities Management staff received a proposal from KJWW Engineering Consultants, PC for the provision of code review and design services, production of construction bidding documents, bidding assistance and construction administrative services and negotiated a fixed fee contract in the amount of \$64,500 plus reimbursables.
- It is in the best interest of the County to enter into a contract with KJWW Engineering of Chicago, Illinois.
- This contract for engineering services is being made in accordance with Section 5-101(3) of the Lake County Purchasing Ordinance and the Local Government Professional Services Selection Act (50 ILCS 510/1 et seq).

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby directed to negotiate and enter into a contract with KJWW Engineering Consultants, PC of Chicago, Illinois for Engineering design services for a fire alarm system for Division of Transportation buildings in Libertyville, IL in the amount of \$64,500 plus reimbursables not to exceed \$1,000, charging account 101-1103285-71150-000-000-000-11155 and request its adoption.
