Joint resolution approving an emergency appropriation to accept the Illinois Department of Commerce and Economic Opportunity (DCEO) American Recovery and Reinvestment Act reallocation grant for Dislocated Workers in the amount of \$24,181.

- The Illinois Department of Commerce and Economic Opportunity has provided reallocated funds under the American Recovery and Reinvestment Act to the Lake County Workforce Development Department in the amount of \$24,181.
- The grant is for the fiscal year July 1, 2010 to June 30, 2011, for training for dislocated workers.
- An emergency appropriation of \$24,181 for county fiscal year 2011 is requested to allocate these funds into the Workforce Department's budget and authorize acceptance of this grant.

WHEREAS, the Illinois Department of Commerce and Economic Opportunity has provided a grant under the American Recovery and Reinvestment Act to the Lake County Workforce Development Department in the amount of \$24,181; and

WHEREAS, the grant is for the fiscal year July 1, 2010 to June 30, 2011, for training for dislocated workers; and

WHEREAS, an emergency appropriation of \$24,181 is requested to allocate these funds into the Workforce Department's county fiscal year 2011budget and authorize acceptance of this grant.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that that an emergency appropriation in the amount of \$24,181 for the Workforce Development Department is hereby approved and that the 1GS Training for Dislocated Workers Grant is hereby accepted.
