Joint resolution appropriating \$900,000 of County Bridge Tax funds and \$4,500,000 of Matching Tax funds for the reconstruction and widening of North Avenue from IL Rte. 83 to Deep Lake Road and designated as Section 03-00119-09-WR.

- North Avenue (IL Rte. 83 to Deep Lake Road), Reconstruction and Widening: Appropriation
- This widening and reconstruction improvement is included in the 2009 program.
- Before a project letting can be held, an appropriation of \$900,000 of County Bridge Tax funds and \$4,500,000 of Matching Tax funds is necessary.

**WHEREAS**, North Avenue (*County Highway 3*) is a designated route on the county highway system; and

**WHEREAS**, it would be beneficial to the safety and welfare of the motoring public if North Avenue from IL Rte. 83 to Deep Lake Road could be reconstructed and widened; and

**WHEREAS**, plans, specifications and estimates of costs for this improvement have been completed and this improvement is now ready to proceed to a project letting; and

**WHEREAS**, before a project letting can be held an appropriation of funds is needed.

**NOW, THEREFORE BE IT RESOLVED** by this County Board of Lake County, Illinois, that there is hereby appropriated \$900,000 of County Bridge Tax funds and \$4,500,000 of Matching Tax funds for the reconstruction and widening of North Avenue from IL Rte. 83 to Deep Lake Road and designated as Section 03-00119-09-WR.
