Joint Resolution appropriating \$50,000 of Matching Tax funds to provide maintenance of stormwater basins, signing and fence replacements along county highways and designated as Section 08-00000-15-GM.

- Road Enhancements 2008: Appropriation
- The county has several stormwater management basins that initially require annual maintenance and care.
- Other locations need to be identified for signage.
- Before a contract letting can be held, an appropriation of funds is needed for \$50,000 of Matching Tax funds.
