## **Legislation Text**

Joint resolution authorizing the execution of a new master agreement between Lake County and the Greater Round Lake Fire Protection District regarding provisions for emergency pre-emption systems to be included in current and future traffic control signals under the jurisdiction of the Lake County Division of Transportation.

- County Signals; New EVPS Master Agreement: Greater Round Lake Fire
- Protection District
- Emergency Vehicle Pre-emption Systems (EVPS) were installed on traffic signals on County Highways within the boundaries of Greater Round Lake Fire Protection District.
- The EVPS equipment is currently maintained by the Greater Round Lake Fire Protection District.
- Lake County is revising all EVPS agreements into master agreements so that the local agency will be responsible for maintenance and future cost of the emitters and LCDOT will be responsible for maintenance and future cost for preemption systems.
- The new traffic signal master agreements with the agency include provisions regarding the
  maintenance cost, construction and installation cost, and future costs associated with current and
  future County owned traffic control signals.

## RESOLUTION

**WHEREAS**, Lake County by and through its Division of Transportation has jurisdiction and ownership of the traffic control signals and equipment at intersections equipped with emergency vehicle pre-emption systems (EVPS) and located within the Greater Round Lake Fire Protection District area of jurisdiction; and

**WHEREAS,** by prior agreement between Lake County and the Greater Round Lake Fire Protection District, the above-said emergency vehicle pre-emption systems were and are maintained at the expense of the Greater Round Lake Fire Protection District; and

WHEREAS, Lake County and the Greater Round Lake Fire Protection District now desire to enter into a master agreement providing the terms and conditions by which the Greater Round Lake Fire Protection District will be financially responsible for the maintenance and future costs of the emitters associated with the emergency vehicle pre-emption systems and Lake County will be responsible for maintenance and future costs of the emergency vehicle pre-emption systems that would be under the jurisdiction of the Lake County Division of Transportation and within the Greater Round Lake Fire Protection District area of jurisdiction, a draft copy of said agreement is attached hereto; and

**WHEREAS**, it is in the best interest of Lake County to authorize the County Engineer of Lake County to include additional emergency vehicle pre-emption systems within future traffic control signals, as may be warranted from time-to-time, and are under the jurisdiction of Lake County and within the master agreement between Lake County and the Greater Round Lake Fire Protection District.

**NOW, THEREFORE BE IT RESOLVED**, by this County Board of Lake County, that the Chair of the County Board, the County Clerk, and the County Engineer of Lake County, Illinois, be authorized, and they are hereby directed to execute a master agreement by which the Greater Round Lake Fire Protection District will be financially responsible for the maintenance and future cost of the emitters associated with the above-said emergency vehicle pre-emption systems and Lake County will be responsible for maintenance and future costs of the emergency vehicle pre-emption systems at said intersections. The County Engineer shall transmit in writing the final agreement to be executed by the Chair of the Lake County Board and the County Clerk.

**BE IT FURTHER RESOLVED** that the County Engineer of Lake County is hereby authorized to include within the above-said master agreement between Lake County and the Greater Round Lake Fire Protection District additional traffic control signals, as may be warranted from time-to-time, and that are within the jurisdiction of Lake County Division of Transportation in accordance with said master agreement.

**BE IT FURTHER RESOLVED** that the above-said master agreement takes the place of and supersedes all prior agreements relative to the maintenance of emergency vehicle pre-emption systems in accordance with the said master agreement.
