- Tree Maintenance 2008: Appropriation
- The county has planted many trees and shrubs on various projects on the county highway system that initially require annual maintenance and care.
- Before a contract letting can be held, an appropriation of funds is needed.
- The appropriation is \$50,000 of Matching Tax funds.
