Description: **Title:** Housing and Community Development Commission

**Purpose/Function:** The Commission is responsible for overseeing local administration of the Federal Community Development Block Grant Program, HOME Investment Partnerships Program, and the Emergency Solutions Grant Program and other homeless assistance programs. The Commission is responsible for developing the Consolidated Housing and Community Development Consolidated Annual Action Plan by identifying community needs, setting priorities, and establishing goals. The Commission uses these goals to help determine which activities to fund on an annual basis.

**Term of members/trustees:** Board Members 2 years; Expires December 1; Municipal Officials and citizens four year terms; Expires April 30.

**Composition:** The HCDC consists of fifteen appointed and two ex-officio members. The appointed members are nominated by the County Board Chairman and approved by the County Board. The fifteen members include: five representatives from the County Board, five Mayors, Village Presidents, or Township Supervisors, and five Lake County residents. The ex-officio members are the County Board Chair and the Chair of the County Board Health and Community Services Committee
