Joint resolution accepting the Illinois Department of Commerce and Economic Opportunity (DCEO) Trade Globalization Adjustment and Assistance Act grant modification and authorizing an emergency appropriation in the amount of \$12,972.

- DCEO has provided a modification to the Trade Globalization Adjustment and Assistance Act grant to the Lake County Workforce Development Department in the amount of \$12,972.
- The grant is for the term of October 1, 2011 to September 30, 2012, which includes funding for individuals certified as eligible under the Act.
- This funding is expected to cover training services for workers affected by fifteen plant closings or layoffs.
- An emergency appropriation of \$12,972 is requested to be approved to allocate these funds into the Workforce Department's county fiscal year 2012 budget and authorize acceptance of this modification.

**WHEREAS,** The Illinois Department of Commerce and Economic Opportunity has provided modifications to the Trade Globalization Adjustment and Assistance Act grant to the Lake County Workforce Development Department and,

**WHEREAS,** the total grant for Lake County Workforce Development is \$12,972 and

**WHEREAS,** this grant is for the fiscal year October 1, 2011 to September 30, 2012, to provide funding individuals certified under the Act; and

**WHEREAS**, this funding is expected to cover training services for workers from fifteen plant closing and lay-offs;

**WHEREAS**, an emergency appropriation of \$12,972 is requested to allocate these funds into the Workforce Department's county fiscal year 2012 budget and authorize acceptance of this grant.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$12,972 for the Workforce Development Department is hereby approved and that the Trade and Globalization Adjustment and Assistance Act be accepted. A chart of accounts is attached.
