Joint resolution authorizing a contract with Northern Air Systems, Inc. of Grayslake, Illinois in the amount of \$46,320 for improvements to the HVAC system at the Public Works Administration Building.

- The Public Works Administration Building is in need of improvements to the HVAC system.
- An invitation to bid for the HVAC upgrade for the Public Works Administration Building was issued and invitations were extended to 20 vendors.
- Sealed bids were received from three vendors with responses ranging from \$29,000 to \$59,830; the
 lowest bid was withdrawn at the request of the bidder due to an error in their bid submittal.
- Northern Air Systems, Inc. of Grayslake, Ilinois is the lowest responsive and responsible bidder who best meets the needs of the County.
- This contract will cost the County the amount of \$46,320.

RESOLUTION

WHEREAS, in accordance with Section 4-102 of the Lake County Purchasing Ordinance, bids were called for by publication for the Upgrade to the HVAC for the Public Works Administration Building; and

WHEREAS, subsequent to said publication, an invitation to bid was extended to 20 vendors; and

WHEREAS, sealed bids were received from 3 vendors and opened in the office of the Public Works Department in Libertyville on Tuesday, March 11, 2014; at 2:00 p.m.; and

WHEREAS, based on the criteria set forth in the Invitation to Bid; the staff evaluated all bid submittals and determined that the bid submitted by Northern Air Systems, Inc. of Grayslake, Illinois is the lowest responsive and responsible bidder who best meets the needs of the County.
