Joint resolution executing an agreement with Community College District Number 532, College of Lake County, stating the terms and conditions by which the College of Lake County will provide permanent and temporary easements to accommodate the construction of the Washington Street Multi-Use Path along the south side of Washington Street, from Atkinson Road to Lancer Lane, and designated as Section 09-00135-11-BT.

- Washington Street Multi-Use Path, Atkinson Road to Lancer Lane, Permanent and Temporary Easement, College of Lake County: Agreement.
- In order to provide for this improvement, additional permanent and temporary easements are required from the College of Lake County.
- This resolution authorizes the execution of an agreement between Lake County and the College of Lake County for this improvement.
- This agreement has been approved by the College of Lake County on March 25, 2014.

RESOLUTION

WHEREAS, Lake County, by and through its Division of Transportation, proposes to construct a bike path along the south side of Washington Street, County Highway 45, from Atkinson Road to Lancer Lane; and

WHEREAS, it would be beneficial to the safety and welfare of the motoring public if Washington Street could be improved with the construction of a bike path to connect to the existing path at the

southeast corner of Atkinson Road to the existing path at the southwest corner of Lancer Lane; and

WHEREAS, the construction of said bike path will require additional permanent and temporary easements owned by the College of Lake County; and

WHEREAS, the College of Lake County and Lake County desire to enter into an agreement stating the terms and conditions by which the College of Lake County will provide said additional permanent and temporary easements, a draft copy of which is attached hereto.

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that the County Board Chair, the County Clerk and the County Engineer of Lake County are authorized and they are directed to execute an agreement stating the terms and conditions by which the College of Lake County will grant to Lake County said permanent and temporary easement, for the above-named improvement designated as section 09-00135-11-BT.

BE IT FURTHER RESOLVED that the County Engineer shall transmit, in writing, the final agreement to be executed by the County Board Chair and the County Clerk.
