Joint resolution appropriating \$545,000 of Matching Tax funds and \$120,000 of Motor Fuel Tax funds for annual bituminous maintenance of various roads and bike paths on the County highway system, and designated as Section 15-00000-13-GM.

- 2015 Bituminous Maintenance: Appropriation.
- Each year, the County undertakes maintenance of its bituminous highway pavements, shoulders, and bike path pavements to preserve the surface quality.
- Before a project letting can be held, an appropriation of \$545,000 of Matching Tax funds and \$120,000 of Motor Fuel Tax funds is necessary.

### **RESOLUTION**

**WHEREAS**, in order to preserve the condition of the bituminous highway pavements, shoulders, and bike path pavements on the designated routes on the County highway system and the County bike path network, the Division of Transportation annually undertakes work, where necessary, including pavement patching, pavement shoulder repairs, bike path resurfacing and bike path seal coating, hereinafter, bituminous maintenance; and

**WHEREAS**, the estimated cost of bituminous maintenance activities for 2015 is \$665,000.

**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board, that there is hereby appropriated \$545,000 of Matching Tax funds and \$120,000 of Motor Fuel Tax funds for bituminous maintenance for fiscal year 2015 on various County highways and bike paths, and designated as Section 15-00000-13-GM.

**BE IT FURTHER RESOLVED** that this appropriation be processed by the County Engineer for final approval of the Illinois Department of Transportation in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County, dated January 18, 2013.
