Joint resolution appropriating \$615,000 of Motor Fuel Tax funds for the resurfacing of Quentin Road, from Lake Cook Road to Long Grove Road, designated as Section 15-00051-10-RS.

- Quentin Road Resurfacing, Lake Cook Road to Long Grove Road: Appropriation.
- Quentin Road, from Lake Cook Road to Long Grove Road, is in need of resurfacing.
- This resurfacing improvement has been identified within the County's pavement management system, and is included in the 2015 program.
- Before a project letting can be held, an appropriation of \$615,000 of Motor Fuel Tax funds is necessary.

## RESOLUTION

**WHEREAS**, Quentin Road, County Highway 5, is a designated route on the County highway system; and

**WHEREAS,** it would be beneficial to the safety and welfare of the motoring public if Quentin Road, from Lake Cook Road to Long Grove Road, is resurfaced; and

**WHEREAS,** plans, specifications and estimates of costs for this improvement have been completed, and this improvement is now ready to proceed to contract letting; and

WHEREAS, before a construction letting can be held, an appropriation of funds is needed.

**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board, that there is hereby appropriated \$615,000 of Motor Fuel Tax funds for the resurfacing of Quentin Road, from Lake Cook Road to Long Grove Road, and designated as Section 15-00051-10-RS.
