Joint resolution authorizing the execution of an agreement with the Village of Lake Zurich, stating the terms and conditions for the intersection improvement of Ela Road, at U.S. Route 12, and designated as Section 14-00144-18-CH.

- Ela Road, at U.S. Route 12, Intersection Improvement: Village of Lake Zurich Agreement.
- U.S. Route 12, at the intersection of Ela Road, will be improved with right turn lanes, traffic signal
 modifications, and the installation of pedestrian accommodations as part of the improvement being
 designed for the Village of Lake Zurich's Congestion Mitigation and Air Quality (CMAQ) project.
- The County will oversee the construction of this improvement and provide the local share of construction costs for the intersection improvement.
- This resolution authorizes the execution of an agreement with the Village of Lake Zurich, providing for the change of Local Agency Designation for CMAQ project implementation and the division of costs.

RESOLUTION

WHEREAS, Ela Road, County Highway 60, is a designated route on the County highway system; and

WHEREAS, it would be beneficial for the safety and welfare of the motoring public if U.S. Route 12, at the intersection of Ela Road, could be improved; and

WHEREAS, in 2000, the Village of Lake Zurich received approval to utilize federal Congestion Mitigation and Air Quality (CMAQ) funding for the addition of right turn lanes on U.S. Route 12, at the intersection of Ela Road: and

WHEREAS, the Village of Lake Zurich and Lake County are desirous of entering into an agreement for said improvement, changing the Local Agency Designation for the CMAQ project implementation, a draft copy of which is attached hereto.

WHEREAS, the County will oversee the construction of said improvement and provide the local share of the intersection improvement costs; and

NOW, THEREFORE BE IT RESOLVED by this Lake County Board, that the County Board Chair, the County Clerk, and the County Engineer of Lake County are authorized, and they are directed to execute on behalf of Lake County, an agreement, for the intersection improvement of Ela Road, at U.S. Route 12, and such authorization shall include any subsequent amendments.

BE IT FURTHER RESOLVED that the County Engineer shall transmit, in writing, the final agreement, and any subsequent amendments, to be executed by the County Board Chair and the County Clerk.
