- The Village Board approved the agreement on March 10, 2015.

## **RESOLUTION**

**WHEREAS**, Lake County, by and through its Division of Transportation has jurisdiction over various street name signs located within the Village of Long Grove; and

**WHEREAS**, the Village of Long Grove desires to install and maintain Village owned street name signs at the intersections of County highways and public streets within the Village limits; and

**WHEREAS**, this installation will be beneficial to the Village of Long Grove and Lake County as a whole; and

**WHEREAS**, the Village of Long Grove and Lake County are desirous of entering into a master agreement pertaining to the installation of said street name signs, a draft copy of which is attached hereto.



**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board, that the County Board Chair, the County Clerk, and the County Engineer of Lake County are authorized, and they are directed to execute a master agreement pertaining to the installation, operation and maintenance of Village owned street name signs at the intersections of County highways and public streets within the Village limits.

**BE IT FURTHER RESOLVED** that the County Engineer shall transmit, in writing, the final agreement to be executed by the County Board Chair and the County Clerk.
