Joint resolution authorizing a contract with Geske and Sons, Inc., Crystal Lake, Illinois, in the amount of \$298,761.72, for hot-mix surface removal, Class D patching and constructing hot-mix asphalt leveling binder and surface course lifts on Chevy Chase Road, from Gilmer Road to the Mundelein village limit, in the Fremont Township Road District, and designated as Section 16-07114-01-GM.

- 2016 Fremont Township Road District: Contract Award.
- A total of three bids were received ranging from \$298,761.72 to \$389,846.72, with Geske and Sons, Inc., Crystal Lake, Illinois, being the lowest responsible bidder with a contract amount of \$298,761.72.

## RESOLUTION

**WHEREAS**, pursuant to authority granted by this Lake County Board and the Fremont Township Road District Highway Commissioner, the County Engineer heretofore called for sealed bids, by publication, for hot-mix surface removal, Class D patching and constructing hot-mix asphalt leveling binder and surface course lifts on Chevy Chase Road, from Gilmer Road to the Mundelein village limit, in the Fremont Township Road District, and designated as Section 16-07114-01-GM; and

**WHEREAS,** pursuant to said publication and calling for said bids, sealed bids were received and opened on April 12, 2016, at 10:00 A.M. at the Lake County Division of Transportation in Libertyville, Illinois, a tabulation of said bids being as follows:

Geske and Sons, Inc. Crystal Lake, Illinois \$298,761.72 Peter Baker & Son Company Lake Bluff, Illinois \$322,475.92

J.A. Johnson Paving Company Arlington Heights, Illinois \$389,846.72

**WHEREAS**, the Public Works and Transportation Committee, the County Engineer and the Purchasing Agent have examined each bid, and it appears that the lowest responsible bidder is Geske and Sons, Inc., Crystal Lake, Illinois, their bid being \$298,761.72, based on estimated quantities and unit prices; and

**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board, that a contract be awarded to said Geske and Sons, Inc., Crystal Lake, Illinois, in accordance with their bid of \$298,761.72, based on estimated quantities and unit prices, and that the Purchasing Agent, the County Clerk, and the County Engineer of Lake County be authorized and they are hereby directed to enter into a contract with said low bidder for the hot-mix surface removal, Class D patching and constructing hot-mix asphalt leveling binder and surface course lifts on Chevy Chase Road, from Gilmer Road to the Mundelein village limit in the Fremont Township Road District, and designated as Section 16-07114-01-GM.

**BE IT FURTHER RESOLVED** that in as much as such estimated quantities are the best approximation that can be determined at this time, these quantities may be added to, deducted from, or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 and Section 6-701.1 without further Board action.

**BE IT FURTHER RESOLVED** that this award be processed by the County Engineer for final approval of the Illinois Department of Transportation in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County, dated January 18, 2013, and subject to the approval of the Fremont Township Road District Highway Commissioner.
