Joint resolution authorizing a first amendment to an agreement for sewage disposal with the Village of Fox Lake to provide sewer service to 31682 N US Highway 12 in Lakemoor, Illinois.

- The owner of the parcel at 31682 N US Highway 12 in Lakemoor, Illinois, which is currently occupied by Fratellos Restaurant, has requested sanitary sewer service from the providers of sewer service in the North West Lake facility planning area (FPA) to transport and treat its sewage discharge.
- The sewage from this parcel will discharge into the local sewer, owned by the Lakes Region Sanitary, then be transported via the County Northwest Interceptor Sewer and delivered to the Fox Lake Northwest Regional Water Reclamation Facility (WRF) for treatment.
- This resolution authorizes a first amendment to an agreement for sewage disposal by and between the County of Lake and the Village of Fox Lake.

## RESOLUTION

**WHEREAS**, the County of Lake (County) and the Village of Fox Lake (Village) have previously entered into an Agreement for Sewage Disposal dated July 15, 2010; and

**WHEREAS**, the Parties desire to amend the boundary of the County Northwest Service Area to include a 1.99 acre parcel commonly known as 31682 North US Highway 12, which is currently occupied by Fratellos Restaurant; and

**WHEREAS**, the parcel is proximate to an existing sanitary sewer main located in the Village of Volo, which connects to the County Northwest Sewer Interceptor and is delivered to the Village for treatment; and

**WHEREAS**, the owner of the parcel has requested to connect to the Village of Volo sanitary sewer main; and

**WHEREAS**, the County and the Village have determined they can readily provide sanitary sewer service to the parcel; and

**WHEREAS,** the County and the Village desire to enter into this Amendment to enlarge the County Northwest Sewer Service Area and provide sewer service to the parcel; and

WHEREAS, execution of said Amendment must be authorized by Resolution of this County Board.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that the Chair of the County Board and the Clerk of said County be and they are hereby authorized and directed to execute the attached First Amendment to Agreement for Sewage Disposal by and between the County of Lake and the Village of Fox Lake, in the form substantially herein.
