Joint resolution appropriating \$1,525,000 of Matching Tax funds for the 2016 microsurfacing of Rollins Road, from Hook Drive to Illinois Route 132, and designated as Section 16-00080-61-RS.

- 2016 Microsurfacing of Rollins Road, from Hook Drive to Illinois Route 132: Appropriation.
- Microsurfacing is a pavement preservation technique.
- Rollins Road, from Hook Drive to Illinois Route 132, is in need of microsurfacing.
- This microsurfacing improvement has been identified within the County's pavement management system, and is included in the 2016 program.
- Before a project letting can be held, an appropriation of \$1,525,000 of Matching Tax funds is necessary.

RESOLUTION

WHEREAS, Rollins Road, County Highway 31, is a designated route on the County highway system; and

WHEREAS, it would be beneficial to the safety and welfare of the motoring public if Rollins Road, from Hook Drive to Illinois Route 132, could be microsurfaced; and

WHEREAS, this project will consist of crack sealing and patching prior to applying the microsurfacing, applying a two-pass microsurfacing course, and applying new permanent pavement markings; and

WHEREAS, plans, specifications and estimates of costs for this improvement have been completed, and this improvement is now ready to proceed to contract letting; and

WHEREAS, before a construction letting can be held, an appropriation of funds is needed.
