- Based on the criteria set forth in the Request for Proposals, an interdepartmental evaluation committee comprised of Human Resources, Finance and Administrative Services, Sheriff's Office, Lake County Forest Preserve, Court Administration and the County Administrator's Office selected Matrix Consulting Group, Chicago, Illinois, as the most favorable proposal for Lake County.
- This contract will cost the County an estimated amount of \$91,500.

**WHEREAS,** in accordance with Section 5-102 of the Lake County Purchasing Ordinance, proposals were called for by publication for a Payroll and Human Resources Operations Assessment for Lake County; and

**WHEREAS,** subsequent to said publication, requests for proposals were extended to 52 vendors; and

**WHEREAS,** sealed proposals were received from eight vendors and opened in the County Building, Waukegan, Illinois, on August 11, 2016 at 2:00 p.m.; and

**WHEREAS,** an evaluation committee comprised of representatives from Human Resources, Finance and Administrative Services, Sheriff's Office, Lake County Forest Preserve, Court Administration and the County Administrator's Office held interviews with the top three firms; and

WHEREAS, based on the criteria set forth in the Request for Proposal, the Evaluation Committee comprised of representatives from Human Resources, Finance and Administrative Services, Sheriff's Office, Lake County Forest Preserve, Court Administration and the County Administrator's Office selected Matrix Consulting Group, Chicago, Illinois, as the most favorable proposal for Lake County; and

**NOW, THEREFORE, BE IT RESOLVED,** by this County Board of Lake County, Illinois, that the Purchasing Agent is authorized to enter into a contract with Matrix Consulting Group, Chicago, Illinois, for a Payroll and Human Resources Operations Assessment for the term of October 12, 2016 through April 30, 2017 in the estimated amount of \$91,500 charged to account number 101-1102040-71150.
