WHEREAS, Lake County Sheriff's Office identified a cooperative purchasing contract with Brunswick Commercial and Government Products, Inc. of Edgewater, Florida, through General Services Administration (GSA) to procure the marine patrol boat that was competitively solicited and awarded.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is authorized to enter into a contract with Brunswick Commercial and Government Products, Inc. of Edgewater, Florida, for a Sheriff's Office marine patrol boat in the estimated total amount of \$134,149, charged to account number 206-1440010-72180.
