- There are three existing chillers in the Lake County Courthouse used to provide chilled water to cool the facility.
- There is a need to perform maintenance to add an epoxy coating to extend the life and preserve the
 efficiency of an existing chiller installed at the Lake County Courthouse.
- The scope of work provided by Trane includes providing an industrial grade protective coating.
- Lake County Facilities identified a cooperative purchasing contract with the Trane Company,
 Willowbrook, Illinois, through United States (US) Communities to procure the repair work that was competitively solicited and awarded.
- Pursuant to Article 10-101 of the Lake County Purchasing Ordinance, Cooperative Purchasing, Lake
 County may participate in a cooperative purchasing agreement for the procurement of goods with one
 or more public procurement units in accordance with an agreement entered between the participants.
