Joint resolution appropriating \$810,000 of Motor Fuel Tax funds for the resurfacing of Gelden Road, from Deep Lake Road to Grass Lake Road, which will be improved under the Illinois Highway Code for a total of 1.29 miles, and designated as Section 17-00147-02-RS.

- Gelden Road needs resurfacing, from Deep Lake Road to Grass Lake Road.
- This resurfacing improvement has been identified within the County's pavement management system, and is included in the highway improvement program.
- Before a project letting can be held, an appropriation of \$810,000 of Motor Fuel Tax funds is necessary.

### **RESOLUTION**

**WHEREAS**, Gelden Road, County Highway 66, is a designated route on the County highway system; and

**WHEREAS**, it would be beneficial to the safety and welfare of the motoring public if Gelden Road, from Deep Lake Road to Grass Lake Road, could be resurfaced; and

**WHEREAS**, plans, specifications, and estimates of costs for this improvement have been completed, and this improvement is now ready to proceed to contract letting; and

**WHEREAS**, before a construction letting can be held, an appropriation of funds is needed; and

**NOW, THEREFORE BE IT RESOLVED** by this Lake County Board, that there is hereby appropriated \$810,000 of Motor Fuel Tax funds for the resurfacing of Gelden Road, from Deep Lake Road to Grass Lake Road, which will be improved under the Illinois Highway Code for a total of 1.29 miles,

and designated as Section 17-00147-02-RS.

**BE IT FURTHER RESOLVED** that the Clerk is hereby directed to transmit four certified originals of this resolution to the district office of the Department of Transportation.

**BE IT FURTHER RESOLVED** that this appropriation be processed by the County Engineer for final approval of the Illinois Department of Transportation in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County, dated January 18, 2013.
