NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby directed to enter into a contract with exp US Services, Inc., of Chicago, Illinois for mechanical, electrical, and structural consulting engineering services at the Depke Juvenile Complex, Lake County Traffic Court, and the Children's Advocacy Center in the amount of \$52,570 and will be managed by Facilities Department of Finance and Administrative Services and charged to account #101-1103285-82020.
