  the promotion of economic development in the county.
- Funding for the professional service agreement is provided in the Fiscal Year (FY) 2018 budget and is subject to annual budgetary appropriations and an evaluation of the effectiveness of LCP in achieving the County's economic development objectives.
- Pursuant to Article 6, Section 102 of the County's Purchasing Ordinance, the Purchasing Agent consulted with an ad hoc review group that approved a bid exemption on the basis of an existing long standing, successful relationship.

## RESOLUTION

**WHEREAS**, the Lake County Board created the Lake County Partners (LCP) in 1998 to represent the County in matters pertaining to economic development; and

**WHEREAS**, section 55 of the Illinois Compiled Statutes (ILCS) 5/5-1005 (21), authorizes the County to appropriate and expend funds from the county treasury for economic development purposes, including the making of grants to any other governmental entity or commercial enterprise deemed necessary or desirable for the promotion of economic development in the county; and

**WHEREAS**, the professional agreement provides for a two-year agreement with three one-year renewals; and

**WHEREAS**, funding for the professional service agreement is provided in the FY2018 budget and is subject to annual budgetary appropriations and an evaluation of the effectiveness of LCP in achieving the County's economic development objectives; and

**WHEREAS**, pursuant to Article 6, Section 102 of the Lake County Purchasing Ordinance, the Purchasing Agent consulted with an ad hoc review group that approved a bid exemption on the basis of an existing long standing, successful relationship.

**NOW, THEREFORE, BE IT RESOLVED,** by this County Board of Lake County, Illinois, that the County Board Chairman is authorized to enter into a professional service agreement with Lake County Partners, to represent Lake County in matters pertaining to economic development in the amount of \$387,000 with renewal options charged to account # 101-1102030-72730.
